Rent Café is the Santa Clara County Housing Authority's online portal platform where new applicants can sign up for SCCHA's Housing Choice Voucher (Section 8) Interest List.

Once you complete registration and you are finished signing up, you will be placed on the SCCHA Interest List. After registering, you can log in anytime to view or update your account information.

#### **Please Note:**

- You will not receive updates on the status of your application. You'll hear from us if you are selected.
- You are not assigned a specific number, so there is no spot on a waiting list. Instead, applicants are selected through a random lottery.
- Vouchers are issued randomly by computer, and we cannot provide a timeframe or guarantee of selection.

- If you are selected, we will notify you by mail, phone, and email. Voucher issuance details will not appear in the online portal. If you do not respond to our contact attempts, you will be removed from the list and will need to reapply.
- Please keep your contact information up-to-date at all times.
- To keep your application active, **log in at least once every 6 months**. If you do not log in within this timeframe, your application will **no longer be active**.
